the ^{on motion} minutes of the previous meeting were read and approved, the board then inspected the various caucus tickets presented by the various caucus Inspectors, it was moved by Ole Benson supported by August Krans, that the board approve the same and that the Clerk be instructed to cause the same to be printed with motion prevailed by all the members present the Township Treasurer then presented his ^{Statement} and the account books were checked and the same were found to correspond it was moved by August Krans supported by Adolf Forsberg that the Treasurer ^{Statement} be approved and that the same be placed on record with motion was

unanimously carried it was moved by August Krans supported by Ole Benson to fix the township treasurer bonds to the amount of \$ 5000.⁰⁰ (five thousand dollars) for the next ensuing year with motion was duly carried by all the members of the board. It was further moved by August Krans supported by Ole Benson to fix the Clerks bonds at the amount of \$ 150.⁰⁰ one hundred and fifty dollars with motion was duly carried by all the members of the board
