 day of April. A.D. 1901.

The conditions of the above obligation is such that if the
 above named Olof Anderson. shall faithfully discharge
 the duties of his office as Township Treasurer of the
 Township of Bates in the County aforesaid and shall
 Faithfully and truly account for and pay over
 according to law. all moneys which shall come
 into his hands as such Treasurer then the said
 obligation to be void otherwise to remain in full
 force and effect.
