

Township of Bates November 17<sup>th</sup> 1902.

A Meeting of the township board of the Township of Bates was held at the office of the township Clerk on the 17<sup>th</sup> day of November A.D. 1902.

Meeting called to order by the Chairwoman.

Clerk called the roll and the following members was present Charley Olson Supervisor Israel Carlsson Clerk. Victor Forsberg and Olof Tjyborn. Justice of the peace.

Minutes of last meeting was read and approved

The following resolution was offered by Olson, and its adaptive was moved by Carlsson and supported by Tjyborn. Whereas the Commissioner of highways have exceeded his authority in laying out a highway named the Gustafsons road in awarding Damages of \$167<sup>50</sup> one hundred and sixty seven Dollars and fifty cents, and whereas the law does not allow the highway commissioner to lay out a road when the expenses exceeds \$100<sup>00</sup> without the township Board concurring according to section 4040 of compiled Laws of 1897. therefore be it resolved that the proceeding of said highway Commissioner in laying out said road be declared void.

The roll was called on the above resolution Olson yes. Carlsson yes. Forsberg yes. Tjyborn. yes Vote being for the adoption of said resolution Moved by Carlsson. Seconded by Forsberg that board allow Hagemer Lundgerill \$ 7<sup>00</sup>
