to settle up with the Township
Treasurer and as the Treasurer
orders were corresponding with the Clerk's
account book, it was moved by
Carlson seconded by Sjoqvist that
the settlement with the Treasurer
be accepted. Board then proceeded
to make out detailed statement of all
orders issued during the year and
Clerk was instructed to cause said
statement to be printed. Board then
proceeded to set the bond of the

Treasurer and Clerk for the ensuing year
It was moved by Sjoqvist seconded by
Frybom, that Treasurer bond be set to
\$ 5000.⁰⁰ Dollars and Clerk bond to
\$ 1000.⁰⁰ Dollars for the ensuing year
