

Bater Township Feb 18th 1905

A meeting of the Township Board of the Twp of Bater was held at Clerk's office on the 18th Day of Feb AD 1905.

Meeting was called to order by the Chair Clerk called the roll with the following Members Present Odolf Forsberg Supervisor Victor Benson Clerk

Peter Fogqvist Emil Soderqvist Justice of the Peace. Minutes of last meeting was read and approved as read. The Board then proceeded to discuss a question brought up by the Chairman in regard to the Demond match Company. Therefor whereas it appears that some certain lands owned by the Demond match Company have been erroneously assessed therefor be it resolved that a rebate of 33% be allowed to the said D M Company provided that the other 67% be paid to the Twp Treasurer before the 5th Day of March 1905 and further more as it appears to be necessary to construct a Bridge on the August Johnson Road on Section 30 T. 43 R. 34 and whereas Iron River Township has offered to contribute with \$40⁰⁰ and Plank to cover said Bridge provided that the Township of Bater would contribute with the sum of \$40⁰⁰ and said money to be paid on the completion of said Bridge therefor be it further resolved that the Township of Bater hereby agrees to pay the sum of \$40⁰⁰ towards the said Bridge in the manner aforesaid
