

Township of Bates. March 28th 1905

A meeting of the township board was held at the office of the township clerk on the 28th day of March A.D. 1905. Meeting was called to order by the chairman Forsberg. Clerk called the roll with the following members. Adolf Forsberg Supervisor. Victor Benson. Clerk. Peter Sjogvist. Emil Soderquist Justice of the peace.

Minutes of last meeting read and approved and the board then proceeded to settle with the Town Treasurer. and as the treasurers books was corresponding with the Clerks books. it was moved by Soderquist. Seconded by Sjogvist. that the settlement with the Town Treasurer. be accepted and approved. The board then proceeded to make out a detailed statement of all the orders issued and to whom issued and for what purpose. and the clerk was instructed to cause said statement to be printed. The board then proceeded to fix the bond for the Township Treasurer and clerk for the ensuing year. and it was therefor moved by Sjogvist seconded by Soderquist that the Township Treasurers bond be fixed at \$5000⁰⁰ Dollars. for the next ensuing year. and the Town Clerk's bond at \$1000⁰⁰ Dollars which motion prevailed by all the members of the board. and it was moved and supported that the two tickets filed by the clerk be called the Farmers and Taxpayers Ticket and the clerk be instructed to cause said ticket to be printed. Motion carried. The board then went into committee of the whole for the purpose of auditing and allowing the following bills brought before the board for consideration it was moved by Sjogvist seconded by Soderquist that the following bills be allowed. Chairman. and clerk then proceeded to draw orders upon the proper funds as follows.
