A meeting of the township board was held in the town hall on the 14th day of April A. D. 1915 at 9 o'clock A. M.

The meeting was called to order by V. Benson the following members being present

Moved by Aught Johnson supported by Hedstrom that we appoint Louis Olsen Health Officer for the ensuing year
motion carried unanimously

Moved by Hedstrom supported by Johnson that Mrs. V. Benson be authorized to scrub the town hall when ever the board deems it necessary for the ensuing year

for rental of Town hall for the ensuing year.

that John Hansen be appointed Custodian
of the Town hall and that he is to received
\$2.00 per night for each and all dances.
motion carried unanimously

Motion made by Johnson supported by Hedstrom
that we charge \$8.00 per night for out side
parties and \$5.00 per night for local parties
for such purposes as dances & church purposes
and the hall to be given free for social
benefits & parties for people living in the
township
motion carried unanimously

Moved by Hedstrom supported by Johnson that
we pay John Hansen two dollars per night
to open up and take care of the town hall
during any dances and entertainments
motion carried unanimously

Motion made by Johnson supported by
Hedstrom that the Highway Commissioner
be paid at the rate of \$2.50 per day for
services performed for the ensuing year.
