Motion carried.

An account of the death of Mr. W. Sennmore, his widow, Mrs. Anna Sennmore was left in such poor circumstances that it was necessary for the Township Board to assist her. Consequently a house with furniture and clothing was provided for her. The Bills for the same are in the Clerk's office.

It was moved by Le Clair supported by Gustafson that the highway Commissioner be authorized to purchase two pair of wheel scrapers.
