John Hanson having been called upon to serve as township clerk and having refused to do so, meeting was called to order by Gendzwill. C. Johnson was appointed Clerk. Protem.

A vacancy existing in the office of supervisor of said, it was moved by Ernest Johnson seconded by Gendzwill that Anna C. Johnson be appointed to fill said, vacancy as supervisor of said township until the next ensuing ~~year~~ election. Ayes: - Johnson, Gendzwill. Nays: - None. Whereupon said Anna C. Johnson did lawfully qualify as supervisor of said township, the oath administered by Joseph Gendzwill, Justice of the Peace. Both of Office. Signed, subscribed, sworn to and filed.

Moved by Ernest Johnson and seconded by Joseph Gendzwill that the official ballots for the next ensuing election be ordered printed and that in accordance with Certification of Citizens Party Committee, the name of Anna C. Johnson be printed on said ballot as said Party Candidate for the office of supervisor of said Bates Township in the place and instead of Johner Johnson withdrawn. Ayes: - Gendzwill Ernest Johnson Nays: - None. Anna C. Johnson not Voting.

Whereupon it was moved by Gendzwill seconded by Ernest Johnson that the board do check up and settle the Township accounts; the Treasurer being present with his books, accounts and Vouchers. Ayes Gendzwill, C. Johnson Anna C. Johnson. Nays: - None.

Whereas the board having only partly settled with the Treasurer, at 5:30 o'clock P.M., it was decided to adjourn until Wednesday Mar 22nd, 1922 at 9 o'clock A.M.
