

Meeting of the Bate Township Board on June 16, 1923, with the following members present, Carlson, Johnson, Lindquist and Waite. Minutes of the last meeting read and approved.

It was moved by Carlson and seconded by Lindquist that the Township Board heartily indorses the efforts and services of the Upper Peninsula Development Bureau of the past, and the sum of one hundred dollars be appropriated to the Upper Peninsula Development Bureau for the purpose of assisting its work. Vote on above motion, yes. Carlson Johnson, Lindquist and Waite. Nays None. Motion Carried.

It was moved by Johnson seconded by Lindquist that a new roof be put on the Bate Township hall. Vote on above motion, yes. Carlson Johnson Lindquist and Waite. Nays None. Motion Carried.

The following resolution was offered by Lindquist who moved its adoption;

Whereas ~~there~~ it appears that the Road Repair Fund of the Township of Bate, Chon Co., Michigan is exhausted, no money remaining therein, and

Whereas, it appears that the Highway Improvement Fund is likewise exhausted, no money remaining therein, and

Whereas a condition exists with reference to said funds which makes it imperative and necessary that the said township borrow money for said funds in anticipation of the collection of taxes for the current year, in order that the work of said township in road repair and highway improvement may be carried on.

Therefore be it resolved, that the township of Bate will borrow sums of money for said two funds up to the maximum amount allowed by law, at a lawful rate of interest.

Be it further resolved, that the Supervisor and Clerk of said township, be and they are hereby appointed a committee to negotiate and complete said loans consistent with the terms hereof.

Be it further resolved, that the said Supervisor and Clerk be and they are hereby appointed and empowered, by this Board for and in behalf

of said township, to make execute and deliver to the person or persons, firm or firms Corporation or Corporations, banking or otherwise, the necessary and proper evidences of debt covering said loans.

Which resolution was seconded by Johnson and passed by the following vote, Yeas Johnson, Carlson, Lindquist and Waite. Nays None.
