Resolution. In case any person or persons cut any windfalls that may fall across the highways in this township such person or persons must in order to receive any compensation therefore notify the Highway Commissioner on what road he or she place such wind falls were cut. and whenever the township board deems proper they will authorize the Highway Commissioner to look over such work and appraise the amount to be paid for such work

Resolved further, that the Township Clerk be and is hereby instructed to draw notices of this Resolution and post the same in at least three public places in the township

Resolution. Resolved that the Clerk be instructed to take the numbers and to make out a Statement of such orders that a special highway tax was levied for during the year 1894 and be it further Resolved; that the township treasurer be and is hereby instructed to not pay any of such orders unless there is any money in the treasury collected for what is called the special highway fund. the foregoing Resolution was adopted. by Forsberg Trans Carlson Otto says none carried.
