

Township of Bates June 3rd 1901.

A Meeting of the Township Board of the Township of Bates was held at the office of the Township Clerk on the 3rd day of June A.D. 1901.

Meeting called to order by the Chairman
Clerk called the roll and the following members was present. Charley Olson Supervisor
Israel Carlson Clerk Edward Sjogquist and Victor Benson. Justice of the Peace.
Minutes of last meeting was read and approved as read

The following Resolution was offered by Benson and its adoption was moved by Carlson, and supported by Sjogquist. whereas Gustaf Erickson, appeared at this meeting before the board and asking said board for a partial support for himself and his wife as he are not able to support himself and Olof Worsen, also appeared and asking for help as to partially refrain Doctor expenses incurred in case of a crippled child therefore be it resolved by us the Township board assembled at this meeting to allow Gustaf Erickson \$10⁰⁰ as a partial support, and Olof Worsen \$25⁰⁰ as to refrain Doctor expenses incurred in case of said child. the roll was called on the above resolution and resulted as follows. Olson yes. Benson yes. Sjogquist yes. Carlson, yes. the votes being for the adoption of the resolution.

the board then went into committee of the whole for the purpose of auditing and allowing the following bills brought before the board for consideration it was moved by Sjogquist seconded by Benson that the following bills be allowed and the Chairman and Clerk be instructed to issue orders for the same upon the proper fund of Bates Township upon which the same are allowed and the Chairman and Clerk then proceeded to draw orders for the same as follows:
