

Township of Bates April 1st 1902.

A Meeting of the Township board of the Township of Bates was held at the office of the Township Clerk on the 1st day of April A. D. 1902.

Meeting called to order by the Chairman Clerk called the roll and the following members was present. Charles Olson. Supervisor Israel Carlsson Clerk. Victor Benson and Victor Forsberg Justice of the peace.

Minutes of last Meeting was read and approved as read. Moved by Carlsson, seconded by Benson that the bonds of Township Clerk be fixed to one thousand Dollars, and the Treasurers bond to Five thousand Dollars, for the ensuing year. Motion Unanimously carried.

Moved by Carlsson seconded by Benson that the two election tickets filed by the Clerk be accepted and that Clerk be instructed to cause the same to be printed which motion prevailed. The board then proceeded to settle up with the Township Treasurer, and as the Treasurers books was corresponding with the Clerks books it was moved by Carlsson seconded by Benson that the settlement with the Township Treasurer be accepted. Moved and seconded that the rejected tax of \$ 31²⁴ cents collected by Township Treasurer, be added to the contingent fund. Motion carried

Board then went into committee of the whole for the purpose of auditing and allowing the following bills presented for consideration Moved and seconded without any objection that the following bills be allowed, and that bill presented by Mey Hospital, be led over for further consideration said bills amounts to \$ 45 ⁸⁰/₁₀₀
