

Township of Bates April 14th 1902.

A Meeting of the Township Board of the Township of Bates was held at the office of the Township Clerk on the 14th day of April A. D. 1902.

Meeting called to order by the chairman Clerk called the roll and the following members was present. Charley Olson Supervisor Israel Carlsson, Clerk. Victor Benson and Victor Forsberg Justice of the peace

Minutes of last Meeting was read and approved as read. Clerk then presented his official bond and it was moved by Benson, seconded by Forsberg that Clerks bond be accepted, which motion was duly carried. The board then proceeded to fix the Highway Labor for the ensuing year, and it was moved by Carlsson, seconded by Benson, that the wages for Highway Labor for the ensuing year be fixed as follows. For a man with team \$4⁰⁰ per day and for a man laboring \$1⁷⁵ per day, which said motion prevailed all the members voted in favor of the motion. Board then went into Committee of the whole for the purpose of auditing and allowing the following bills presented to the board for consideration, moved by Benson seconded by Forsberg that the following bills be allowed and the Chairman, and Clerk be instructed to issue orders for the same, and the Chairman and Clerk then proceeded to draw orders as follows.
