

Township of Bates December 22nd 1903.

A meeting of the Township Board of the Township of Bates was held at the office of the Township Clerk on the 22nd day of December A. D. 1903.

Meeting called to order by the Chairman. Clerk called the roll with the following members present Adolf Forsberg Supervisor, Israel Carlsson, Clerk, Olof Trybom and Peter Sjogvist, Justice of the peace. Minutes of last meeting read and approved, as read. The following resolution was offered by Forsberg, and its adaptation was moved by Trybom and supported by Carlsson. Whereas the poor fund is overdrawn to a great extent, therefore be it resolved that the Supervisor be instructed to reduce the monthly support of Mrs Lundqvist from \$18⁰⁰ to 8 Dollars per month. Yes Forsberg Carlsson, Trybom, Sjogvist Nays. None. Resolution adapted and carried.

There was presented several bills to the board for service rendered in scabber favor case occurred in the township, and the same was acted upon by the board and delivered to the Supervisor to be transferred to the County Board.

Board then went into committee for the purpose of auditing and allowing the following bills presented for consideration and it was moved by Sjogvist, seconded by Trybom that the following bills be allowed and Chairman and Clerk was instructed to draw orders for the same.
