

Township of Bates March 31st 1903.

A meeting of the township board of the township of Bates, was held at the office of the Township Clerk on the 31st day of March A.D. 1903.

Meeting called to order by the Supervisor ^{Chairman}.

Clerk called the roll and the following members was present. Charly Olson supervisor.

Israel Carlson Clerk. Victor Forsberg and Olof W. Tzybom. Justice of the peace.

Minutes of last meeting was read and approved moved by Carlson. Seconded by Forsberg that Clerks bond be set to \$1000⁰⁰ Dollars for ensuing year and Treasurers Bond to \$5000⁰⁰ Dollars for the ensuing year, which said motion prevailed by all voting in favor of it. Moved by Carlson seconded by Forsberg that the two election tickets presented by the Clerk be rejected, and Clerk be instructed to have said tickets printed motion carried the board then proceeded to settle up with the Township Treasurer and it was found that.

Contingent order no 377. Issued July 8, 1898 to Chas Ollor amount \$1⁰⁰ was presented and faced \$10⁰⁰

Highway orders no 90. issued Dec 9th 1898 to Adolf Gustafson amount \$5⁰⁰ presented and faced \$10⁰⁰

" " no 68 Issued Oct 31st 1898 Adolf Gustafson amount \$1⁰⁰ presented and faced \$10⁰⁰

and as the balance of the Treasurers orders was corresponding with the Township Clerks books. it was moved by Forsberg seconded by Tzybom that the settlement with the Township Treasurer be rejected. the board then proceeded to make out a detailed statement of all the orders issued and to whom issued and for what purpose the orders was issued and the Clerk was instructed to cause said statement to be printed in not less than five and not more than fifty copies as required by act 261 of the Laws of 1897.
