

Township of Bates April 10<sup>th</sup> 1905.

Pursuant to call by Charley Olson Supervisor a meeting of the Township Board of the Township of Bates, was held at the office of the Township Clerk on the 10<sup>th</sup> day of April A.D. 1905.

Meeting was called to order by the Chairman.

Clerk called the roll with the following members present. Charley Olson, Supervisor Israel Carlson, Clerk Peter Sjogvist, Emil Soderqvist, Justice of the Peace.

Minutes of Last Meeting read and approved as read.

The Township Clerk then presented his official bond and after being examined by the board it was moved by Sjogvist seconded by Soderqvist that Clerks bond be approved which motion was duly carried.

The Highway Commissioner then presented his official bond and it was moved by Soderqvist seconded by Sjogvist that the bond of Highway Commissioner be approved which motion was duly carried.

The board then proceeded to appoint one Health officer for the ensuing year, and it was moved by Soderqvist seconded by Peter Sjogvist, that Edward Sjogvist be appointed Health officer for the ensuing year. Motion carried. Board then went into committee of the whole for the purpose of auditing and allowing the following bills brought before the board for consideration, and after said bills was examined it was considered by the board that bill presented by E. Tannerman on \$12.<sup>87</sup> for Drugs and Medicin in small cases be refered to county Board, and it was moved by Sjogvist seconded by Soderqvist that the other bills presented be allowed and Clerk and Chairman be instructed to draw orders for the same as follows:
